Pursuant to the Policy, the share price utilized to calculate the number of shares issued was the 20-day trailing average closing price as of the last day of the quarter, or \$60.97.

2. The Reporting Person is a partner and serves as Head of Strategic Investments at Carlson Capital, L.P. ("Carlson Capital"). Carlson Capital may be deemed to beneficially own 162,617 shares of Common Stock of the Issuer. The Reporting Person disclaims beneficial ownership of the securities of the Issuer beneficially owned by Carlson Capital.
